


# 3 System description





## 6 Before use

## 6.1 Initial start-up and longer breaks in use

- Sterilize the X-Smart 5:1 AL contra-angle handpiece, the handpiece sleeve, the file clamp, and lip clip cable and lip clip before initial startup.
- > Clean and care the X-Smart 5:1 AL contra-angle handpiece after longer breaks in use.
- > Charge the foot control completely before the first use.

## 6.2 Before each patient

#### IMPORTANT

#### Cable inspection

Inspect the cable of the charger, the handpiece, the lip clip, and the file clamp before and after each use. If you detect wear or tear of the cables, contact the service center.

#### 🗥 WARNING

#### Danger of a defective file due to incorrect motor calibration.

Perform a system calibration before every treatment and every time a contra-angle handpiece is changed.







- Press on the "Up" icon at the right of the desired file.
   The file is positioned further up in the overview.
- 3. Press on the "Down" icon at the right of the desired file.
  - ✤ The file is positioned further down in the overview.

#### 7.4.6 Changing the sequence name

- ✓ The "My sequences [→ 40]" dialog is open.
- 1. Press on the "T" icon next to the desired sequence.
  - ⅍ The input window opens.
- 2. Correct the name.
- 3. Press on "OK".
  - ⅍ Return to the "My Sequences" dialog.

#### 7.5 Changing the file / file sequence during treatment

#### Changing the file sequence during treatment

- ✓ The "Treatment without apex location [→ 27]" or "Treatment with apex location [→ 31]" dialog is open.
- 1. Press the "File sequence collection" icon.
  - ✤ The window with an overview of the sequences of the "File Sequences" and "My Sequences" categories opens.
- 2. Press the desired category.
  - ✤ The selected category turns orange.
- 3. Press the desired sequence within this category.
  - Return to the original main dialog with the preferred sequence. The depicted file is the first file in the sequence overview order.

**Tip:** Under the category "File Sequences", your favorites (marked with a star symbol) are found at the top. See more under "Sequences [→ 39]".

#### Changing the file during treatment

- ✓ The "Treatment without apex location [→ 27]" or "Treatment with apex location [→ 31]" dialog is open.
- 1. Press on the illustrations of the files left/right (if multiple files are present in a sequence).
- 2. Repeat this step until you reach the desired file within this sequence.

**Tip:** The illustrated order of the files reflects the order within the file overview in a sequence. The file order of the sequences under "My Sequences" can be personalized. See more under "Changing the order of the files  $[\rightarrow 51]$ ".

## 7.6 Recommendation for the treatment procedure

#### WARNING

#### Infection due to contaminated file clamp / lip clip during treatment

> When the file clamp and the lip clip are removed from the patient, they must be stored under sterile conditions.

#### 🔥 WARNING

#### Risk of file breakage due to fatigue fracture

The patient could inhale broken files and choke.

To prevent fatigue fracture as much as possible, use only fully intact, undamaged files.

#### 

# Improperly selected speeds and torque values can endanger the patient!

Improper settings can cause treatment errors or file fracture.

The files require different working techniques. Always observe the file manufacturer's specifications.

#### Broken or falling files!

Risk of choking

Place a dental dam in the patient's mouth to prevent the risk of choking.

#### 🔥 WARNING

#### Incorrect measurement!

Tissue damage and infection due to incorrect measurement!

- When using the apex locator function, use only endodontic files with metal shafts to ensure a proper apex length determination. Using files without a metal shaft may lead to an incorrect apex length determination and therefore to an under or over instrumentation with risk of injury for the patient.
- The different file systems require different working techniques. Always observe the file manufacturer's specifications.
- · Work without exerting any pressure on the file.
- The apex locator function assists preparatory work for root canal treatment. The number of X-rays can be reduced with X-Smart Pro+. However, you must always take at least one X-ray image to determine the depth for preparatory work. A clinical evaluation



including knowledge of the anatomy of root canals is important for interpreting the results.

- When performing the apex location, wear non-conductive gloves. This will prevent inaccurate measurements caused by undesired leakage currents. During the measurement, the contra-angle handpiece must not come into contact with the patient's mucosa, metallic dental restorations, or the lip clip.
- If the file stops moving, remove the file by gently pulling it toward the coronal end.

#### IMPORTANT

Inspect the file for damage or deformation (untwisting) and then replace it if necessary.

## 7.7 Calibrating the drive

#### MARNING

Danger of a defective file due to incorrect motor calibration.

Perform a system calibration before every treatment and every time a contra-angle handpiece is changed.

#### Interval:

Before each patient

Cal Cal

- ✓ The unit is switched on and the contra-angle handpiece is attached to the motor.
- 1. In the main menu, select one of the main dialogs with the calibration icon.
- Press the calibration icon. Calibration must be confirmed in a window.
- **3.** When calibration has been completed successfully, a green check mark can be seen next to the icon.

## 7.8 Using the finger switch

To be able to start and stop the motor using the finger switch, the finger switch option must be set in the settings menu.  $[\to 43]$ 

The finger switch functions as a button.

- Press button briefly: the motor starts
- Press button briefly again: the motor stops

Additional functionality of the finger switch in combination with the LED function, see "LED functionality [ $\rightarrow$  55]".

## 7.9 Operating the foot control

The foot control functions as a pedal:

- Press the foot control down: the motor starts
- Release the foot control: the motor stops




#### 7.9.1 Charging the foot control

- ✓ A USB charger is at hand.
- **1.** Plug the charging cable into the USB charger.
- 2. Plug the charging cable into the charging socket of the foot control.
  - ✤ The LED lights up orange. For more on the LED display, see "Description of foot control".
  - $\,\, \ensuremath{\mathfrak{b}}$   $\,$  When the LED goes out, the battery is charged.


#### 7.9.2 Pairing the foot control with the unit

- ✓ The foot control is charged prior to initial operation.
- Go to "Settings" of the X-Smart Pro/Pro+ and select the operating mode "Foot Control"(A).





- 2. Press the pin (B) onto the pairing button (C) on the back of the foot control for three seconds.
  - ✤ The status LED switches from flickering to flashing. The foot control is ready for pairing.
- Go to "Settings" of the X-Smart Pro/Pro+ and select "Foot Control Pairing".



- 5. When pairing is successful, the serial number of the foot control is shown on the monitor. A blue frame around the serial number
  - indicates that pairing was successful.
- 6. Press the foot control and test the connection.

## 7.10 LED

#### 7.10.1 Adjusting the brightness

The brightness of the LED is continuously adjustable.

To adjust the LED, move the slider in the Settings/General settings menu to the desired position.



To switch off the LED, move the slider to the far left position.

If a contra-angle handpiece is attached to the handpiece while setting, the current LED brightness can be checked directly.

#### 7.10.2 LED functionality

If the LED is not switched off, the following functions are available:

- LED is lit while motor is running
- LED remains lit
- LED is lit without the motor running

#### LED is lit while motor is running

When the motor is started, the LED is also automatically switched on.

#### LED remains lit

After the motor is stopped, the LED remains lit for 5 seconds.

#### LED is lit without the motor running

The LED can also be switched on without starting the motor at the same time. There is a difference whether the finger switch or the foot control is used.

- Finger switch: to enable it to light up without starting the motor, the finger switch must be pressed longer than 1 second.
- Foot control: to enable it to light up without starting the motor, the foot control must be pressed lightly, not all the way down.

The LED is lit as long as the finger switch / foot control is held and then remains lit for 5 seconds.

## 7.11 Conducting a cable test

#### Interval:

- Before each patient
- ✓ You are in the "Settings"/"Cable Check" dialog
- > Follow the instructions on the display.
- In all categories, a successful test is indicated by a green check mark.
- If the test is unsuccessful, go back one level in the dialog and repeat the cable test. If there are difficulties conducting tests, look for potential interference, see more at "Troubleshooting and repair [→ 71]".

## 7.12 Using the apex locator

The apex locator can be used to determine the working length of the root canal file for endodontic treatments using electrical impedance.

The apex locator can be used as follows:

- For apex location using a file clamp
- For apex location during treatment with the motor for endodontic treatment

#### 

#### Under or over instrumentation due to electromagnetic interference!

The apex locator can be affected by electromagnetic fields. This may lead to measurement errors. Strong influence is indicated by red flashing of the distance display.

Ensure that there are no sources of electromagnetic interference close to the device.

When the apex locator detects a defect, an error message is displayed.

For more settings of the apex locator and simulation of the distance display, see "Settings / Apex locator [ $\rightarrow$  42]".

For more information about the distance display, see "Distance display  $[\rightarrow 57]$ ".

#### 7.12.1 Connecting the apex locator set

#### For treatment with apex location

- ✓ File clamp and lip clip incl. cable are sterilized and ready.
- **1.** Connect the apex locator adapter cable to the unit (A).
- 2. Attach the lip clip to the lip clip cable.
- 3. Insert the lip clip cable into the apex locator adapter.

#### For manual apex location

- ✓ File clamp and lip clip incl. cable are sterilized and ready.
- ✓ The apex locator adapter is connected to the unit.
- The lip clip is connected.
- 1. Insert the file clamp into the apex locator adapter.
- 2. Press on the button of the file clamp and clamp a file firmly.

#### 7.12.2 Check apex locator system

Before starting apex location, a functional test can be conducted by shorting the electrodes.

- Short the electrical system. Hold the inserted files directly against the lip clip.
  - If the test was successful, a green check mark is displayed between the lip clip and contra-angle handpiece / file clamp.
  - If a green symbol does not appear, check the electrical connections for damage. See the "Troubleshooting and repair [→ 71]" section for other measures.

#### 7.12.3 Distance display

 $-\infty$ -

Treatment progress is shown in the distance display on the user interface. This shows the distance from the root canal file to the physiological apex (apical foramen). The root canal is divided into three colored regions in the distance display.

#### 🔥 WARNING

#### The distance display is not a metric specification of length.

The ApexLocator should be used as an additional aid to supplement the usual root canal treatment measures. It does not replace the radiological determination of the working length. To determine the exact length, also make the relevant X-ray images.

#### Colored regions of the distance display

#### Blue region

Corresponds to the coronal/medial section. The tip of the root canal file is near the entrance to the canal.



#### Green region

Corresponds to the apical region. The tip of the root canal file has reached the apical region, but not yet reached the mid-apical region (two green arrows, see below).





#### Orange region

Corresponds to the apical region. The tip of the root canal file has reached the apical region, and has passed the mid-apical region (two green arrows, see below).

Tip: If a 3-color scale (blue, green, red) for the distance display is preferred, it is possible to display the orange region as green. To do this, change the setting under "Settings"/"Apex Locator Settings". If the 4-color scale is deselected, displaying the "Doctor's Choice" symbol in orange is also omitted.

The last level of the apical region (A) before the "Over" level corresponds to the apical foramen.

#### Red region

Corresponds to reaching the "Over" level. The tip of the root canal file has reached the apex. Over instrumentation is indicated.

#### Two green arrowheads

The two green arrowheads indicate the mid-apical region.



•

#### **Doctor's Choice**

Set your preferred endodontic workflow by setting the working length ("Doctor's Choice"), see more under "Setting working length and function when it is reached  $[\rightarrow 58]$ ".


The working length ("Doctor's Choice") has an effect on the "Signal tones [→ 61]".

#### 7.12.4 Setting working length and function when it is reached

If the sound is not switched off, see "Changing the volume  $[\rightarrow 61]$ ", apex signal tones will sound in addition to the graphic distance display. The intervals between the beeps vary according to the measured distance to the set working length.

#### Set working length

- The "Settings/Apex Locator Settings/Doctor's Choice" dialog is displayed.
- > Use the "up" or "down" arrow keys to set the desired working length. Please note that the distance values are not a metric length measurement!



- b The set distance is shown with a "file icon". If the file is within the green or yellow region, the file is displayed in the color of the corresponding region. Learn more about the colors in section "Distance display [→ 57]".
- A beep sounds when the file approaches the apex or the set working length during manual/motor-driven treatment, see more under "Signal tones [-> 61]".
- A continuous beep sounds when the file has reached or exceeded the apex or the set working length during manual/ motor-driven treatment.
- Apex settings ("Doctor's Choice") are stored permanently.

#### Setting function when working length is reached

It can be set so that when reaching the working length ("Doctor's Choice"), the motor:

- Automatically rotates in the reverse or non-cutting direction until the Finger Switch is pressed in order to stop the motor.
- **(...)**
- > Activate this function by tapping on the *Reverse* key, see more under "Automatically changing the direction of rotation [→ 37]".

The function when the working length is reached can be combined with the torque reverse function, see "Switching torque reverse function on/ off [ $\rightarrow$  60]".

#### 7.12.5 Performing apex location using a file clamp

For an endodontic examination, apex location can be performed using the file clamp and a file.

#### 

#### Incorrect measurements!

Prevent incorrect measurements! Wear non-conductive gloves during apex location to avoid measurement errors caused by unwanted leakage current. During the measurement, the root canal file must not come into contact with the patient's mucosa, metallic tooth restorations, or the lip clip.

#### 

#### Broken or falling files!

#### Risk of choking

- Place a dental dam in the patient's mouth to prevent the risk of choking.
- ✓ The unit is prepared for apex location using the file clamp, see Connecting the apex locator set [→ 56].
- You are in the main dialog "Manual apex location [ $\rightarrow$  30]".



- 1. Attach a root canal file to the file clamp.
- Before starting apex location, a functional test can be conducted by shorting the electrodes. Hold the inserted files directly against the lip clip.
  - If the test was successful, a popup symbol with a green check mark appears, see more at "Testing the measurement system [→ 57]".
  - If no green symbol appears, check the electrical connections for signs of damage. See the "Troubleshooting and repair [→ 71]" section for other measures.
- **3.** Place the lip clip in the patient's mouth and perform the apex location.
  - ⁵ The current root canal depth is shown in the distance display. For more information, see "Distance display". [→ 57]



**Tip:** The two green arrowheads indicate the medial apical region. For more information, see "Distance display". [ $\rightarrow$  57]

## 7.13 Switching the torque reverse function on/off

When the torque reverse function is switched on, the file automatically switches to the opposite/non-cutting direction of rotation when the set torque value is reached. When the pressure on the file is reduced, the motor automatically switches back to the cutting direction.

The torque reverse function can be combined with the function when reaching the working length, see "Setting apex distance and function when reached [ $\rightarrow$  58]".

- ✓ The "Treatment with apex location [ $\rightarrow$  31]" main dialog is displayed.
- > Tap on the *T Reverse* key.
  - If the key is marked orange, the torque reverse function is switched on.



## 7.14 Changing the volume

#### Changing the volume of the unit

- 1. Press the key with the sound icon.
- 2. Change the volume in three stages by putting your finger on the controller (A) and moving it up or down.
  - ✤ The higher up, the louder the volume selected.
  - $\checkmark$  The further down, the lower the volume selected.
  - ♦ At the lowest level, the sound is switched off.

## 7.15 Signal tones

A

#### Apex signal tones

In addition to the graphical distance display on the user interface, the position of the file in the root canal can also be indicated as an acoustic signal.

- Beeps with very long intervals are played when the file is 8 to 9 display levels away from the apex.
- Beeps with long intervals are played when the file is 5 to 7 display levels away from the apex.
- Beeps with short intervals are played when the file is 2 to 4 display levels away from the apex.
- Beeps with very short intervals are played when the file reaches the "Doctor's Choice" set by the user or is one display level away from the apex.
- A continuous beep is played when the file has reached or passed the apex.

You can also switch off the beeps, see "Changing the volume [ $\rightarrow$  61]".

#### Additional beeps

The following additional beeps are played and are not switched off even if the sound is switched off:

- A beep sounds when the set torque value is reached.
- A beep sounds when the motor rotates in reverse direction.
- A beep sounds when 75% of the set torque (Ncm) is reached/ exceeded.

Sounding the beep when 75% of the set torque is reached can be switched off, see under "Settings" / "General Settings".

## 7.16 Perform an update

New updates can be found in the QR code under "Settings" / "Online resources [ $\rightarrow$  43]" or at www.dentsplysirona.com.

- ✓ The unit is not connected to the power supply system.
- ✓ The USB stick is in FAT 32 format.
- 1. Save the software update on the USB stick. Make sure that there are no other data on the USB stick.
- Loosen the screw on the underside of the unit base with a PZ1 wrench and remove the cover. The screw used to fasten the cover is a Torx screw.
- **3.** Remove the battery if the USB stick does not fit next to it. To do this, you must also detach the handpiece cable.
- 4. Connect the USB stick to the USB interface on the unit.
- 5. Connect the unit to the power supply system.
- 6. Switch on the unit.
- Go to "Settings" and tap on the "Update" button.
   A new window opens.
- 8. Confirm implementation.
  - ✤ The update starts and may take several minutes.
- 9. The unit restarts after the update.
- 10. Switch the unit off and disconnect the power plug.
- 11. Remove the USB stick.
- **12.** If you removed the battery, insert it by swiveling it into the housing until it engages.
- 13. Plug the handpiece cable back in.
- Fasten the cover firmly back on the unit base with the same screw.
   Tip: Note the cable and the corresponding cable routing on the unit base.

## 7.17 Replacing the battery

#### 7.17.1 Battery of the unit

- ✓ The unit is switched off.
- 1. Loosen the screw on the underside of the unit base with a PZ1 wrench and remove the cover.
- **2.** Detach the handpiece cable.
- 3. Remove the battery already there.
- **4.** Insert the new battery by swiveling it into the housing until it engages.
- 5. Plug the handpiece cable back in.
- Fasten the cover firmly back on the unit base with the same screw. Tip: Note the cable and the corresponding cable routing on the unit base.
- 7. Connect the unit to the power supply.

#### IMPORTANT

The battery is in protection mode and must be charged to activate it prior to initial use.

#### NOTICE

#### Risk of fire and burns.

Do not open, crush, heat above  $80^\circ C~(176^\circ F)$  or incinerate the battery.

#### 7.17.2 Foot control battery

When the loading cycles of the battery deteriorate, send the medical device to an authorized Dentsply Sirona service partner.

#### NOTICE

Defect or worn out batteries may be replaced only by an authorized Dentsply Sirona service partner.

## 7.18 Replacing the motor

- ✓ The unit is switched off.
- 1. Loosen the screw on the underside of the unit base with a PZ1 wrench and remove the cover.
- 2. Unplug the connected motor cable.
- 3. Plug the new motor cable into the socket.
- Fasten the cover firmly back on the unit base with the same screw. Tip:Note the cable and the corresponding cable routing on the unit base.

## 8 After use

## 8.1 After each treatment session

#### NOTICE

Perform reprocessing immediately after treatment, after 1 hour at the latest.

#### IMPORTANT

#### Cable inspection

Inspect the cable of the charger, the handpiece, the lip clip, and the file clamp before and after each use. If you detect wear or tear of the cables, contact the service center.

#### NOTICE

Use only Dentsply Sirona T1 Spray.

✓ Wear suitable protective clothing.

- 1. Remove the file with tweezers.
- 2. Detach the contra-angle handpiece from the handpiece sleeve.
- 3. Detach the handpiece sleeve from the handpiece.
- 4. Detach the lip clip cable and file clamp from the apex locator adapter.
- 5. Detach the lip clip from the lip clip cable.
- **6.** Peform the "Reprocessing  $[\rightarrow 65]$ ".

## 8.2 At the end of the work day

> Lubricate the contra-angle handpiece with spray [ $\rightarrow$  68].

#### NOTICE

Do not leave a contra-angle handpiece on the straight handpiece overnight to prevent oil from leaking into the electric motor. Never lubricate the electric motor.

## 8.3 Once per work week

- The motor has been conditioned.
- > Lubricate the lock washer [→ 70].

## 9.2 Reprocessing methods

#### 9.2.1 General reprocessing instructions

The general reprocessing instructions apply to the unit in general provided there are no other product-specific reprocessing instructions in the instructions for use.

#### NOTICE

Inappropriate care and cleaning of the unit can result in malfunction or damage. Qualified personnel must be trained in reprocessing medical devices.

Use only care, cleaning, and disinfecting agents approved by the manufacturer.

Reprocessing involves the following steps:

- Cleaning
- Disinfection
- Sterilization if applicable

Perform reprocessing immediately after treatment, after 1 hour at the latest.

Wear suitable protective clothing.

#### NOTICE

Never clean in an ultrasonic bath!

#### NOTICE

Never immerse in disinfectants!

#### 9.2.2 Cleaning and disinfection

#### IMPORTANT

Perform automated reprocessing. Manual reprocessing may be possible in exceptional cases in compliance with the respective national/local requirements.

#### Manual cleaning with a brush

- Thoroughly brush the product under running water (<38°C, <100°F, at least drinking water quality) at least 10 seconds.
- **2.** Use a soft, clean and disinfected brush for thorough cleaning.
- Check at good lighting (min. 500 lux) if the product is clean after reprocessing.
- 4. If there is any contamination, repeat the process.
- 5. Subsequently, if applicable, disinfect/sterilize the product.

#### Manual wipe cleaning and disinfection

#### NOTICE

#### Disinfectants

All disinfectants must be approved in your country and have proven bactericidal, fungicidal and virucidal properties. Use only disinfectants with **no** protein-fixing properties.

Do not use agents containing hydrogen peroxide (H2O2) or chlorine.

We recommend disinfectant cloths FD366 Sensitiv from Dürr.

- 1. For thorough wipe cleaning and disinfection, observe the disinfectant manufacturer's instructions.
- Check at good lighting (min. 500 lux) if the product is clean after reprocessing.
- 3. If there is any contamination, repeat the process.
- Wipe off the disinfectant with a dry, clean and lint-free cloth after it has taken effect.
- 5. If necessary, perform a sterilization afterwards.



#### Automated reprocessing with a washer-disinfector

#### NOTICE

If the unit has not been cleaned in a washer-disinfector, it is essential to conduct manual care and cleaning (see "Manual maintenance  $[\rightarrow 68]$ ").

The washer-disinfector must be approved by its manufacturer for cleaning and disinfecting these products and comply with ISO 15883-1/-2, e.g. 93 °C (200 °F) and 10 min holding time. Refer to the instructions for use of the device for the respective use. After the process, check in good lighting (min. 500 lux) whether the product is clean. If there is any contamination, repeat the process. If necessary, perform a sterilization afterwards.

#### 9.2.3 Manual maintenance

9.2.3.1 Maintenance of mechanical parts

#### Intervals

- Before each sterilization
- After every thermal disinfection without integrated lubrication
- A Spray adapter
- B O-rings for spray adapter
- C Dentsply Sirona T1 Spray

#### NOTICE

Use only Dentsply Sirona T1 Spray.

#### Procedure

- ✓ The spray adapter is disinfected.
- ✓ The O-ring on the spray adapter is intact.
- 1. Fit the spray adapter onto the nozzle of the spray can.
- Insert the contra-angle handpiece until it clicks into place and hold it firmly.
- Spray into the contra-angle handpiece for 1-2 seconds. IMPORTANT: Hold the spray can upright.
- 4. Wipe any spray that comes out with a suitable cloth.
- Repeat the process until the spray that comes out of the contraangle handpiece is clear.

#### 9.2.3.2 Care of the push button chuck

Use Dentsply Sirona T1 Spray on the push-button chuck to remove deposits and ensure proper functioning of the clamping system.

#### Interval

At least once a week

#### Procedure

- ✓ The contra-angle handpiece is clean and disinfected.
- 1. Press the contra-angle handpiece head with the chuck firmly against the spray can nozzle.
- 2. Spray the chuck for 1-2 seconds. IMPORTANT: Hold the spray can upright.
- 3. Wipe any spray that comes out with a suitable cloth.







#### 9.2.4 Sterilization

#### Wrapped sterilization

The product must be cleaned/disinfected according to the table "Overview of the parts to be reprocessed [ $\rightarrow$  65]" prior to sterilization.

The contra-angle handpiece is lubricated according to section "Manual maintenance [ $\rightarrow$  68]".

The product is packed in packaging suitable for sterilization and storage, e.g. paper/laminate packaging or ISO 11607 compliant container.

Steam sterilizers that comply with the requirements of EN 13060, Class B or EN 13060 Class S and are also suitable for the sterilization of these products are approved.

Temperature: 134 °C (274 °F) Holding time: 3 min Overpressure 2.04 bar (29.59 psi) Drying time: 30 minutes

#### NOTICE

Do not exceed 140 °C (284 °F) even during the drying phase.

#### After sterilizing

- Remove the contra-angle handpiece and accessories from the steam sterilizer immediately.
   CAUTIONI The contra-angle handpiece and accessories are hot. Risk of burns!
   NOTICEI Do not attempt to accelerate the cooling process by immersing the contra-angle handpiece in cold water. This will damage the contra-angle handpiece.
- 2. Store the contra-angle handpiece and accessories where they are protected against contamination.
- 3. Sterilize again once the storage period has elapsed.

## 9.3 Inspection, maintenance and testing

Unless otherwise specified in these instructions for use, test all components of the unit for proper functioning on a regular basis and carry out a visual inspection for damage and wear. Replace damaged components if necessary.

Inspect all parts after the cleaning, disinfection and/or sterilization processes. If parts have visible damage after these processes, they must be disposed of and replaced. Signs of visible damage may include discoloration, corrosion, cracks, and other forms of damage.

## 10 Maintenance

## 10.1 Lubricate the lock washer

#### Interval

• 1x weekly

#### Procedure

- 1. Spray some Dentsply Sirona T1 Spray on the stop spring ring (A).
- 2. Turn the lock washer to distribute the Dentsply Sirona T1 Spray.



## NOTICE


Do not use any sharp tools and do not stretch the **new** O-rings.

If the handpiece coupling leaks, the O-rings must be replaced.

- 1. Remove the defective O-rings (A).
- 2. Insert the O-rings one after another. Start with the first groove.
- **3.** Lightly oil the O-ring with Dentsply Sirona T1 Spray.

#### NOTICE

Do not use Vaseline or silicone grease on the O-rings.



## 11 Interference

## 11.1 Error messages

Contact your service technician if one of the following error messages appears on your unit:

- MO\_001: Serious motor error
- AP\_001: Serious apex error
- MC\_001: Serious media controller error

In case of error messages for the insulation test, refer to section "Troubleshooting and repair [ $\rightarrow$  71]".

11.2 Troubleshooting and repair

#### 11.2.1 For error messages related to insulation test

#### For error messages related to insulation test




If a dialog with a combined mode is selected (with apex function), the endodontic unit automatically conducts an internal function test. If the apex insulation in the contra-angle handpiece is faulty, the left symbol appears.

The outer surface of the handpiece is electrically insulated from the apex path of the motor file. After sterilization, liquid may accumulate in the handpiece and bridge the insulation. This results in the apex values being incorrectly displayed when the contra-angle handpiece comes in contact with the patient in the oral cavity.

The following steps can remedy this potential source of interference:

- 1. Remove the contra-angle handpiece from the handpiece.
- 2. Remove the file from the contra-angle handpiece.
- Press compressed air into the file opening with a Sprayvit (or a spray air jet on the treatment center) 3 times for 3 seconds each.

If the yellow symbol is still displayed, put a silicone sleeve on the contra-angle handpiece, for more information, see "Fitting and removing an insulation sleeve [ $\rightarrow$  72]".



#### 11.2.1.1 Fitting and removing an insulation sleeve

#### 🚹 WARNING

#### **Risk of cross contamination!**

The insulation sleeve is not sterile! To avoid cross-contamination Sterilize the insulation sleeve before use.



#### NOTICE

The insulation sleeve is intended for single use. Dispose of the insulation sleeve after each patient.

#### Fitting an insulation sleeve

- You have sterilized the insulation sleeve.
- The motor is at a standstill.
- ✓ A file is **not** clamped in place.
- 1. Pull the insulation sleeve fully over the instrument by gently turning it from one side to the other.
- **2.** Insert the file  $[\rightarrow 47]$ .
- 3. Attach the contra-angle handpiece to the motor.

#### Removing an insulation sleeve


- ✓ The motor is at a standstill.
- 1. Pull the contra-angle handpiece off of the motor.
- 2. Remove the file.
- 3. Remove the insulation sleeve.
- 4. Dispose of the insulation sleeve.

#### 11.2.2 Remedy for pairing problems with the foot control

#### Remedy for pairing problems with the foot control

- Remove metallic objects between the foot control and the drive handpiece.
- Change the position of the foot control.
- Eliminate any sources of interference (e.g. brushed motors, mobile phones, wireless devices, WLAN. etc.).
- Press the reset button of the foot control with the pin and "Pair again  $[\rightarrow 54]".$

If the pairing problem cannot be solved by the remedy, it must be checked by an authorized Dentsply Sirona service partner.
